The **Ministry of Environment** has received financing from the **World Bank** toward the cost of the **Greater Cairo Air Pollution Management and Climate Change Project** and intends to apply part of the proceeds toward payments under the contract for Works of the **Construction of Abuzabal Dumpsite Closure Project (One Lot) of 28 months' duration which consists of the shaping and safe closure of the existing dumpsite using geo-synthetic materials and related installation of gas and leachate collection systems for the solid waste body**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.
2. The Ministry of Environment now invites sealed Bids from eligible Bidders for Works of the Abuzabal Dumpsite Closure Project (One Lot).
3. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's 7<sup>th</sup> edition of "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing of Sept 2025 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Bids will be evaluated in accordance with the evaluation process set out in the bidding documents. The following weightings shall apply for Rated Criteria (including technical and non-price factors): 70% and for the Bid cost: 30%.
5. The Bidding document in **English** language may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of USD 500. The method of payment will be through Bank transfer to the Bank account (the Egyptian Central Bank- The Environmental Protection Fund (EPF)). The document will be sent by airmail for overseas delivery or alternatively by courier services, if so required by the bidder, for overseas delivery against an additional courier charge.

6. Bids must be delivered to the address below on or before **12:00 pm Cairo local time** on **24 March , 2026**. Electronic Bidding will not be permitted. Late Bids will be rejected. The outer Bid envelopes marked “ORIGINAL BID,” and the inner envelopes marked “TECHNICAL PART” will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend, at the address below on **12:00 pm Cairo local time** on **24 March, 2026**. All envelopes marked “FINANCIAL PART” shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
7. All Bids must be accompanied by a Bid Security of **USD300,000.00** (three hundred thousand United States dollars) or its equivalent in EGP and must be valid for a period of **154** days from the Bid submission date (**25 Aug 2026**).
8. All Bids (Technical Proposals) must include a Local Labour Method Statement.
9. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder’s beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
